


#### **Strategy Description**

Passage Dividend Appreciation invests in the stocks of mid-tolarge-cap U.S. and international companies with robust balance sheets, consistent earnings, attractive valuations, and stable dividend growth. These companies are evaluated based on the strength of their financials, management prowess, and cash-flow generating ability. The strategy generally has a U.S. large-cap value tilt although the total opportunity set also includes mid-cap stocks and is not restricted by geography.


